ENERGY LOUISIANA, LLC CONTRACT FOR GREEN PRICING SERVICE

This Agreement is made between Entergy Louisiana, LLC (the "Company") and (the "Customer"), collectively the "Parties".

WHEREAS:

YOUR NAME

The Louisiana Public Service Commission ("LPSC" or the "Commission") in Docket No. R-28271, General Order No. R-28271 approved a two year green pricing tariff ("Tariff"), and

The Company has been authorized by the LPSC in compliance with such Order to offer the Tariff to any customer who requests such service, and

The Customer has requested such service, and

The Company is willing to provide such service to the customer under the terms of the Rider,

THEREFORE, the Parties agree as follows:

1. TERM AND CANCELLATION

The initial term of this Agreement shall be from the date the Company receives this signed Agreement from the participating customer until July 31, 2010.

- If the Customer terminates electric service, this Agreement will be cancelled.
- If the Customer moves to a location within the Company's service territory, this Agreement may be transferred to the new location at the Company's option.
- If the Commission orders that the Tariff be cancelled, the Company shall have the opportunity to cancel this Agreement pursuant to the terms of the applicable Commission order.
- The contract will be automatically extended for the term of the applicable Commission order unless terminated by the customer at least (30) days prior to the end of the initial term. Extensions of the contract will be for contract terms of the applicable Commission Order.
- If this program is cancelled by order of the Commission, the contract will be terminated on the date specified in such order.

The Customer agrees to purchase Green Power block(s) of 100 kilowatt-hours each ("kWh Block(s)") at a Tariff Net Monthly Rate of \$2.25 per kWh Block which shall be in addition to any other applicable rates and charges for electric service. This Tariff Net Monthly Rate is subject to adjustment by the Commission during the Pilot if it appears that the actual costs of implementing the Pilot will exceed the estimate of such costs.

3. The Net Monthly Rate of **DAY** (i.e. 9, 14, 21, etc.) be prorated for **MONTH** month. **YEAR**
